Your privacy when using this site and/or any related site (such as a related mobile application) (the "Site"), is of the utmost importance to us. What information do we collect?

Information You Provide

Information Automatically Collected From You

We and our affiliates, business partners and service providers may automatically collect certain technical information from your computer when you use the Site, such as your Internet Protocol address, your browser type, your operating system, the pages you view on the Site, the pages you view immediately before and after you access the Site, and the search terms you enter on the Site. For example, we collect information and compile statistics about the most and least popular pages on the Site.

This information allows us to recognize you and personalize your experience if you return to the Site using the same computer or device and to improve the Site and the services we provide. We and our affiliates, business partners and service providers may collect this information using "cookies," which are small text files that the Site saves on your computer using your web browser and accesses when you return, or similar technologies.

How do we use this information?

We may use the information we collect for a number of purposes, including, but not limited to: 3/

- providing you with products, services, or information you request;
- providing you with information about the Site or required notices;
- delivering marketing communications, promotional materials, or advertisements that may be of interest to you;

- customizing your experience when using the Site, such as by providing interactive or personalized elements on the Site and providing you with content based on your interests;
- allowing us to improve the Site and the services we provide, such as by better tailoring our content to our visitors' needs and preferences;
- generating and analyzing trends about your and other visitors' use of the Site;
- helping our advertisers and sponsors better understand our visitors; and
- detecting, preventing, and responding to fraud, intellectual property infringement, violations of our Terms of Use, violations of law, or other misuse of the Site.

We also may combine or aggregate any of the information we collect through the Site or elsewhere for any of these purposes.

Under what circumstances do we disclose this information?

We may disclose the information we collect from you through the Site: 4/

- to affiliates, business partners and service providers who work on our behalf, including, but
 not limited to, affiliates, business partners and service providers who, for example, provide
 order and payment processing services; process employment applications on our behalf;
 help us gather and analyze information about usage of the Site; and deliver marketing
 communications, promotional materials, or advertisements that may be of interest to you; 5/
- to affiliates, business partners and service providers who may deliver marketing communications, promotional materials, or advertisements that may be of interest to you; 6/
- as required by law, such as to comply with a subpoena or other legal process, or to comply with government reporting obligations;
- when we believe in good faith that disclosure is necessary (a) to protect our rights, the
 integrity of the Site, or your safety or the safety of others, (b) to detect, prevent, or respond to
 fraud, intellectual property infringement, violations of our Terms of Use, violations of law, or
 other misuse of the Site, or (c) otherwise in accordance with the policies of the World Bank
 Group:
- when we are not otherwise prohibited by applicable law or the policies of the World Bank Group from doing so without your express consent.

In addition, we may share aggregate reports on user demographics and traffic patterns, as well as de-identified information, with third parties.

The Site also may contain links to websites published by third parties. You acknowledge and agree that we are not responsible for the collection and use of your information by such websites that are not under our control. We encourage you to review the privacy policies of each website you visit.
