## DESCRIPTION OF WORK PERFORMED:

June19: I removed some of the caulking on the right side of the toilet and was able to slide a piece of toilet paper underneath. I tested by flushing the toilet multiple times and saw no sign of leaking underneath or around the toilet. June 25: the toilet in the guest bathroom started leaking from the fillvalve onto the floor. I installed a new Kohler 84499 conversion kit and tested. \*The flapper did not require replacement so I left it with Wendy for future use.
