toilet flush is inconsistent. sometimes will flush other times backs up.

DESCRIPTION OF WORK PERFORMED:
 JULY17: When I arrived onsite I flushed a small amount of toilet paper and it clogged right away. I used a 6" toilet auger to clear the toilet blockage. Tested by flushing large rolled up balls of toilet paper with no sign of re-clogging. during testing I noticed the nut on the toilet supply line was cracked. I replaced this supply line with a new braided type supply line. I also noticed the metal sheathing around the shower spray hose was tearing off, this will have to be replaced. JULY19: I returned with a new shower spray hose, installed and tested.
