REASON FOR TODAY'S CALL:

Shower- poor water flow coming out of my hot water tap

DESCRIPTION OF WORK PERFORMED:

July4: I removed the cartridge within the shower valve and found pieces of black rubber stuck inside the hot inlet to the cartridge. I believe this rubber is coming from the hot integral shut off valve. I will cleaned out the cartridge and reinstalled. The valve is in good working order for now but parts will have to be ordered from Paini. AUG13: Jessica ordered a new mixing/pressure balance cartridge, as well as replacement parts for the integral stops. The parts sent for the integral shut off valves were just the stems that actuate the actual shut off valves which appear to be built into the rough in valve. Unfortunately it looks like the only way to replace the actual integrals would be to replace the entire rough in valve. I flushed bits of rubber and debris out of the rough in valve, then I installed the new cartridge. It is currently in good working order but the more the integrals break down the more debris will find its way into this new cartridge.
