REASON FOR TODAY'S CALL:

The white tape around the junction point in the pipe under our washroom sink (please see photo) seems to have worn out as there is some wetness around the area. Not a lot, but it's wet to the touch.

DESCRIPTION OF WORK PERFORMED:

The leaking was coming from the connection between the sink and the mechanical drain body. I loosened the nut that secures the drain body, applied liquid teflon to the threads, and retightened the nut. Tested by filling and draining the sink multiple times with no sign of the leak recurring.
