REASON FOR TODAY'S CALL:

Could you please check all drains (sink and tub) in both bathrooms? The client is complaining about very slow draining - I suspect it could be a stack issue as they are all on the same side. However, the building manager tells me he did not have complaints from any other units *call Rayne for access.

DESCRIPTION OF WORK PERFORMED:

Guest Bathroom: I filled and draided the lavatory sink drain multiple times and it was flowing freely with no sign of backing up. I removed hair from the top of the tub drain and tested by filling the tub 8? and draining. Master Bathroom: I tested the shower by using a rag to plug the drain and filling and draining the shower pan. I found the drain to be a little sluggish. I used the PowerSpin drain snake to clear hair from the drain and tested again. It is now flowing freely. -I removed hair from the top of the lavatory sink drain and tested by filling and draining the sink multiple times.

TECHNICIAN RECOMMENDATIONS:

I'm unsure if this has already been documented but the lavatory sink in the guest bathroom has a hairline crack in it. It doesn't appear to be causing any leaking.
