I used the PowerSpin drain snake to clean the drain and tested again by filling and draining both sides of the sink. The drain is much faster and still no sign of any leaking. I ran the dishwasher through a quick fill drain cycle and still could see no sign of leaking. I asked the tenant to keep an eye on it and if water is noticed below to make note of what was done beforehand that could have caused it.
