REASON FOR TODAY'S CALL:

Toilet that was serviced last time is leaking again, though suspect different part/location. Water is again emptying out of the toilette tank so that periodically I hear the tank refilling. When I turn the water value off overnight, water levels drop in both the bowl and the tank. I have a one piece toilette. About 10 years old. White. Brand unclear. There is no logo/name on the outside and I cannot read what is stamped on the inside of the tank. Don't like that this is wasting water, and in between the tank refiling, when I go to flush, there is often not enough water & pressure for a good flush. Thinking this is not just about the flapper given that was replaced last time - some valve/seal too? I was also wondering if the problem is substantive, whether it is better to replace the toilet. Please advise. Thanks!

DESCRIPTION OF WORK PERFORMED:

There was a tiny bubble forming on the flapper gasket. I used a knife to pop this tiny bubble and showed Catherine how to do this if the bubbles return.
