REASON FOR TODAY'S CALL:

Main Bathroom: Shower cartridge or diverter requires repair. Tenant says when they switch from cold to hot the water pressure drops causing the lower piece on the water faucet to change back to tub faucet mode and not shower head mode.

DESCRIPTION OF WORK PERFORMED:

I removed the trim and handle and found the valve cartridge to be leaking out of the stem. I also noticed the tub spout was loosely connected, and possibly malfunctioning. I replaced the cartridge(Temp ii) as well as the tub spout. The tub spout diverter now stays active no matter hot high you set the temperature but the pressure is still quite low. If the problem persists the rough in valve behind the wall may have to be replaced.

TECHNICIAN RECOMMENDATIONS:

There is cracking in the tile around the tub spout. I used silicone to try and seal it but if the cracking gets worse this tile may have to be replaced.
