DESCRIPTION OF WORK PERFORMED:

-The guest bathroom tub was reported to have leaked to the unit below after a bath with a child. I removed the overflow drain cover and found that the connection between the overflow drain and the tub was not totally sealed. I siliconed around this connection and reinstalled the drain cover. -We flushed the toilet in the master ensuite multiple times and while there was a dripping noise for a minute or so afterward(I believe this dripping to be excess water existing the bowl) it did not seem to
