## REASON FOR TODAY'S CALL:

Leak under kitchen sink. Ensuite toilet not running.

## DESCRIPTION OF WORK PERFORMED:

-I tested the kitchen faucet and sink by filling and draining both sides of the sink and draining multiple times. I saw no sign of leaking. The tenant mentioned afterward that she noticed a few days prior to my visit that the connection between the faucet spray head and spray hose was loose so she tightened it. I believe this connection is likely where the water was leaking from as I do not see any signs of leaking now. -The en-suite toilet fillvalve was not consistently shutting off when the tank was full. I replaced the fillvalve and supply line and tested.
