REASON FOR TODAY'S CALL:

Kitchen Sink: Faucet hose broke off, unable to use sink Dishwasher: foul odour coming from dishwasher, tenant advises issue is getting progressively worse since install 2016. Please advise if appliance tech required.

DESCRIPTION OF WORK PERFORMED:

-The kitchen faucet spray hose was torn and the soonest I could get a replacement from American Standard would have been 2-3 weeks so I replaced the faucet with a new Moen Pullout Deck Faucet and tested. -I did not notice anything wrong with the dishwasher. It just smelled like the food on the plates within it. If the tenant is experiencing foul odours on occasion it could be stagnant moisture within the machine. I would suggest making sure the heat dry function is active on all loads. Also, keeping the door slightly open in between uses may help stop moisture within the machine from stagnating.
