REASON FOR TODAY'S CALL:

We have an unused water filtration system (for drinking) attached to our cold water. Today, the filter burst and flooded the kitchen. I think, if we simply detach the filter and replace the splitter connector with something similar that does not have an extra port, it should be fine. The 6757 photo shows the white tubing that takes water from the cold water to the filter system (maybe replace the brass piece?). The 6759 photo shows the filter system that broke (not important, just fyi)

DESCRIPTION OF WORK PERFORMED:

I removed the 3/8?x1/4? tee used to connect the water filtration supply line, and connected the cold supply line for the kitchen faucet directly to the cold shut off valve. Tested and no other leaks detected. I then removed the water filtration system and used silicone to seal up the hole left in the countertop.
