I was able to reach the Dornbracht rep and he told me that no replacement cartridges were available locally, but that Cantu sold the entire rough in valve assembly. The guys at cantu took the cartridge out of the rough in kit and sold it to me at cost. They have a new cartridge on order and will place it back in the rough in kit so we're not charged for parts we don't need. I installed the new cartridge and tested.
