It will put my landlord's mind at ease to know that everything is okay and if it needs replacement then we will get it done.

DESCRIPTION OF WORK PERFORMED:

AUG29: -The toilet fillvalve was spraying out of the top and the flapper was starting to warp. Before I could repair the toilet I first had to repair the toilet shut off valve by replacing the washer, stem, packing, packing nut, and handle. I then replaced the toilet fillvalve, flapper, and supply line. -The lavatory faucet has integral braided stainless supply lines that appear to be in good shape with no signs of ware. -The dishwasher was replaced not too long ago and the installers used a new braided stainless supply line to connect it. -The laundry supply lines are black rubber and appear to be the originals to the building. I recomend replacement of these hoses.
