Replace wax seal. Replace tub drain trim.

DESCRIPTION OF WORK PERFORMED:

-I lifted the toilet and found the wax seal to be broken but there didn't seem to be any seepage. I cleaned the area under the toilet and reinstalled with a new MaxWax wax ring, tee bolts, and supply line. Tested again and in good working order. -I replaced the tub drain with a new lift & turn style trim kit.
