REASON FOR TODAY'S CALL: Noisy toilet after flushing.

## **DESCRIPTION OF WORK PERFORMED:**

NOV8: It sounded like the water supply to the toilet was being constricted. I first replaced the mechanical portion of the fillvalve(the most likely culprit) but the constriction remained. Before lifting the toilet to replace the supply line and bottom portion of the fillvalve I repaired the wc shut off valve as this can sometimes be the source of the constriction. I repaired the shut off valve by replacing the washer., stem, packing, packing nut, and handle but the flow constriction remained. The next step will be to lift the toilet and reset the supply line and bottom portion of the fillvalve. NOV13: I lifted the toilet and found the floor flange to be 1-1/8" below the finished floor. Instead of using an extension kit to extend the flange up to level, whoever installed the toilet prior to my lifting it simply stacked 2 Kant Leak wax rings on top of one another. I purchased and installed a flange extension kit. I then replaced the bottom portion of the fillvalve and re-set the toilet. I tested and re-siliconed around the base. The toilet is now flushing and filling as it should.
