## REASON FOR TODAY'S CALL:

Kitchen sink: Faucet is leaking in multiple areas.

## DESCRIPTION OF WORK PERFORMED:

I tested the faucet and drainage by filling and draining both sides of the sink and running the dishwasher through multiple fill/drain cycles and saw no sign of leaking above or below the sink. The tenants mentioned the garburator hadn?t worked since they moved in but the garburator wasn?t leaking when draining a sink full of water or when the dishwasher was draining. I tried to repair the garburator but there was something wrong internally with the motor because there is nothing stuck in the grinding chamber but the breaker kept tripping. I replaced the garburator with a new Badger 5 and tested by filling and draining both sides of the sink while running the garburator. -The tenants mentioned they have a dish drying rack that sometimes leaks water onto the countertop. To mitigate the chances of this water on the countertop leaking through to the cabinet below, I siliconed around the kitchen sink lip. I also let the tenants know that any water on the countertop should be wiped up when noticed.
