DESCRIPTION OF WORK PERFORMED:

I cleared the toilet blockage using a 6? toilet auger. During testing I noticed the toilet shut off valve was not working, the fillvalve was taking a long time to refill the tank after a flush, and the flapper was beginning to warp. I repaired the shut off valve by replacing the washer, stem, packing, packing nut, and handle. I then installed a new fillvalve, flapper, and supply line. Tested and in good working order.
