Leak under kitchen sink.

DESCRIPTION OF WORK PERFORMED:

The ABS drain slipjoint adaptor fitting was not glued to the drain. I glued this fitting and tested by filling and draining the sink multiple times. I noticed during testing that the kitchen faucet spray hose was tangled up around the water filter piping. I disconnected the faucet spray hose, untangled it, then reconnected and tested again by filling and draining the sink multiple times.
