REASON FOR TODAY'S CALL:

"There is a mystery leak under the kitchen sink. Tenants were using the garburator in a normal fashion and a big leak happened. A handyman has checked and there is no issue with the garburator. Since this is the case we need you to please do a piping/plumbing/water investigation."

DESCRIPTION OF WORK PERFORMED:

OCT2-i noticed the water stain in front of the bar/counter top right away, then i saw a small access panel. i opened it and noticed what looks like pop lines. they were tied into the drain under the kitchen sink as well as one line tied into the cold water valve, one of the lines was open ended in the wall so any backing up of the kitchen sink drain could have potentially drained out into the wall. OOCT3- removed abs tee that the pop lines drained into and re-piped drainage. cleaned the drain with handheld auger. - removed cold water shut off valve under KS, and replaced with new 1/4 turn style. replaced both supply lines with new braided stainless type removed the pop lines from access panel.
