REASON FOR TODAY'S CALL:

-leak coming from laundry room. believed to be coming from the drains. -faucet in the room next to the laundry room is not working. there is water to it but water will not turn on.

DESCRIPTION OF WORK PERFORMED:

-Kitchen faucet in room beside laundry room was full of debris from a previous water shut down. I replaced the aerator. -laundry room; the 2 machines closest to the washroom we put 1 trap adap on and the other put a crimpco adaptor to help secure the laundry machine drain hoses, brandy wanted to try this first to see if it helps. the washing machine with the trap adaptor on it was going while I was there and it drained perfectly fine. if the washing machines cause another flood in the future i recommend opening the wall to expose the drainage and see how it was piped. while the wall is open we could also install a clean-out. - the leak in ceiling brandy mentioned appeared to be from the previous leak from the washing machines.
