DESCRIPTION OF WORK PERFORMED:

Dec18---Found shower head to be leaking and water was running down the wall, then getting in behind the cover plate. -tub spout was also leaking and running back through the wall. -replaced shower head with one that the tennet had, and replaced tub spout with one of ours. Dec19---inspected shower and tub, ran water through the shower head and the tub spout. Sprayed water up the overflow and all over the shower and tub. Could not see any leaking or signs of water from below. -siliconed tub spout hole and cover plate to seal them both. -tested the drainage and over flow and found no leaks.
