-delete garburator repipe drainage. -inspect tub, lav, and toilet drainage.

DESCRIPTION OF WORK PERFORMED:

-Deleted garburator installed new kitchen sink basket strainer and re-piped drainage. Tested by filling both sinks and draining. -MAIN FLOOR BATHROOM: used PowerSpin drain snake to clear hair from lavatory and tub drains. -TOP FLOOR BATHROOM: the fillvalve was filling the tank to inconsistent levels. When the level of water in the tank was too low the flush would not have sufficient water to create a siphon. I replaced the fillvalve, flapper, and supply line. Tested by flushing rolled up balls of toilet paper.
