REASON FOR TODAY'S CALL:

-loose faucet in master tub. -lavatory drains in master bathroom not draining well and mechanical drain stoppers not connected. -inspect instant hot water dispenser.

DESCRIPTION OF WORK PERFORMED:

-removed hair from both lavatory drains, re-attached mechanical drain stoppers, and tested by filling and draining sinks 3 times. -tightened loose lavatory faucet handles. -the loose roman tub filler tub spout must be re-tightened from below which would require the removal of one of the tiles. -I'll have to try and find a shower spray holster that will fit on this bar or the entire bar may need to be replaced. -the instant hot water and filtration system was removed. this will need to be purchased and installed.

TECHNICIAN RECOMMENDATIONS:

I dropped off a shower spray head holster with the concierge that I believe should fit. No charge for the part.
