REASON FOR TODAY'S CALL:

-water leaking to floor below when son is bathed. *the tub faucet was repaired a couple years ago and the contractor mentioned that the faucet was hard to lock into place and silicone was used to help secure it.

DESCRIPTION OF WORK PERFORMED:

Sep18---i tested the tub faucet and drainage by filling the tub to the overflow, letting the water run through the overflow, and then draining the tub. i saw no signs of leaking during testing. i suspected that water was finding its way through the space between the tub lip and the tiled ledge, to test this i splashed water onto the tile and instantly noticed water running to the underside of the tub. this tile area is not meant to hold large amounts of water but it should be able to handle minor splashing, i will have to return to re-silcone around the tub as the area will have to be completely dry. The braided supply lines for the tub faucet are kinked, I will have to order replacements. Oct15---Replaced braided supply lines for tub faucet and removed and re-siliconed around tub lip.
