## **DESCRIPTION OF WORK PERFORMED:**

The toilet is a Crane, Crane was discontinued some years back. The inside of the tank has a Kohler fillvalve with a clear tube that was disconnected. I reconnected this tube and tested and shortened the length of the flapper chain. The toilet is now flushing on every flush.

## TECHNICIAN RECOMMENDATIONS:

If this toilet has issues in the future I suggest replacing it. The toilet flange is 11" from the back wall. Toilet seat bolt holes are 5-3/4" apart.
