REASON FOR TODAY'S CALL:

I have two issues. The first is low water pressure in my bathroom from both the shower and sink. I think it is just a blocked aerator for both, but am not sure. The second problem is the kitchen sink... There is a sporadic leak from where the faucet joins with the counter. This was happening regularly a couple of weeks ago but has not happened since. My landlord wants it inspected to ensure it doesn't leak extensively while we are out.

DESCRIPTION OF WORK PERFORMED:

KITCHEN FAUCET: I ran the faucet for an extended period of time with no signs of leaking. I believe the connection between the spray head and the spray hose must have become loose at some point, this would account for the type of leaking that was reported. I suggested keeping a Tupperware container under the sink below the spray hose as an early warning that the spray head has worked itself loose and to mitigate any water damage. SHOWER: I replaced the shower head and it now has normal pressure. LAVATORY FAUCET:I replaced the aerator in the guest bathroom lavatory faucet.
