DESCRIPTION OF WORK PERFORMED:

-Used our PowerSpin drain snake to clear the kitchen sink drain blockage. The abs drainage had a few spots that would allow water to seep out, not enough that it was causing damage, but it could get worse. I re-piped the abs drainage and tested by filling both sides of the sink and draining.
