DESCRIPTION OF WORK PERFORMED:
-1st bathroom(to right of entrance): I replaced the toilet fillvalve, flapper, and supply line. I also installed a new toilet seat and shower head(customer supplied). -2nd bathroom: i replaced the flapper but the toilet tank continued to leak into the bowl, I reinstalled the existing flapper and properly connected the chain and it now seems to be flushing as normal.

TECHNICIAN RECOMMENDATIONS:
If the issue in the second bathroom toilet arises again I suggest the tank be removed and re-installed with a new tank to bowl gasket, tank bolts, flushvalve assembly, and supply line.
