-2nd bathroom shower not getting enough Hot water. *Concierge will grant access

DESCRIPTION OF WORK PERFORMED:

---AUG31: I replaced the guest bathroom shower cartridge with new and tested. The water now gets hotter and much faster. ---SEP3: The tenant reported that the water in the guest bathroom shower was still not getting as hot as the master bathroom. I made another visit with a thermometer and measured the temperature in both bathrooms to find that the temperature is consistent in both tub/showers and lavatory sinks.

TECHNICIAN RECOMMENDATIONS:

-The dishwasher does have a smell to it but the drain pipes are clean and garburator is new. It smells like stagnant moisture, I would think that if after a wash the door was left closed with moisture inside it could create this smell. I suggest calling an Appliance technician to see if they have any other ideas as to what could be causing the smell.
