 I replaced the cartridge and then noticed the integral shut off valves were deteriorating and flaking off. We located the main water shut off, repaired the integral stops and re-pressurized the system slowly. Tested and in good working order.

TECHNICIAN RECOMMENDATIONS:  
 It was suggested that all of the integral stops be repaired as they are all probably starting to deteriorate at the same rate as the ones repaired. It would be best to have this done after hours so as to not disrupt the flow of business.
