DESCRIPTION OF WORK PERFORMED:

-The cartridges in the lavatory and kitchen faucets were leaking through the stems. I replaced the cartridges in both faucets and tested. -The toilet fillvalve was malfunctioning, allowing water to continuously run periodically and the flapper was starting to warp. I replaced the fillvalve, flapper, and supply line and tested.
