Tub spout diverter not working.

DESCRIPTION OF WORK PERFORMED:

-The tub spout diverter mechanism was broken internally. I replaced the tub spout with a new Delta Pull-down type diverter spout and tested. -While onsite the tenant mentioned that the kitchen faucet spray head was not switching between spray functions properly. I tried to resolve the issue but could not. The faucet is IKEA and my plumbing wholesalers do not carry parts. The faucet is usable and working fine, it's just that switching between spray functions is a little sticky. The tenant said he wasn't too concerned about it.
