REASON FOR TODAY'S CALL:

"Since we've had the toilet reinstalled it has sill not been functioning too well, however enough not to contact you again. This week however it has stopped being able to flush again. I can clear the water with enough plunging but it doesn't resolve the issue for the next flush."

DESCRIPTION OF WORK PERFORMED:

-When I arrived the toilet was blocked. I used the 6' toilet auger to clear the blockage and removed what apeared to be wet wipes. I tested the toilet by flushing large rolled up balls of toilet paper and the toilet had no problem flushing them. -I also noticed that the flushvalve float was getting caught on the fillvalve causing it to run periodically. I turned the fillvalve slightly so the flushvalve would not catch and tested it quite a few more times with no issues.
