-The kitchen faucet aerator is causing the water to look milky but the air bubbles quickly dissipate. -The master bathroom float arm was rubbing against the back wall of the tank. I shorted the brass float arm and added a slight curve to it. Tested and in good working order. -The guest bathroom toilet requires a conversion kit(84499) this will be ordered and installed in a separate visit.
