REASON FOR TODAY'S CALL:

Shower making rattling noise when turned on.

DESCRIPTION OF WORK PERFORMED:

The noise was emanating from the shower valve. At first I believed it to be coming from the mixing/pressure balance cartridge(PBR40) so I replaced it. After noticing the vibrating had not subsided I re-installed the original PBR40 and removed the diverter spool, tightened a loose integral piece, added some lubrication to it, and reinstalled it. The noise persisted. I finally found that it was the cold integral shut off valve that was causing the vibration. I removed both the Hot & Cold integral shut off valves, cleaned them as best I could, added a small amount of lubrication, and re-installed.

TECHNICIAN RECOMMENDATIONS:

The vibrating has stopped and the tub/shower is functioning normally. If this issue returns I would suggest replacement of the integral shut off valves. Pictures of the Teknobili shower valve were attached to the email thread for future reference.
