The integral stops are not working, to repair these valves a water shut down will have to be scheduled. I called the building manager Amit: 604.323.6270 to schedule a water shutdown. ---May27: I repaired the shower valve integral stops by replacing the washers, stems, packing, and packing nuts. I then replaced the shower valve mixing/pressure balance cartridge and installed new trim as the existing one was missing parts. Tested and in good working order.
