REASON FOR TODAY'S CALL:

Clogged sink. We have a double sink with a garbage disposal on one side. The garbage disposal has been pushing a little water into the other side of the sink for a few days, and now it's completely clogged and only draining very slowly. We suspect a clog below the garbage disposal. The complete clog happened while the dishwasher was running and although it completed its cycle, it also didn't drain fully. The garbage disposal is elderly and we're not committed to keeping it if it turns out to be the problem.

DESCRIPTION OF WORK PERFORMED:

I used the PowerSpin drain snake to clean the kitchen sink drain blockage. Tested by filling and draining both sides of the sink multiple times. I also ran the dishwasher through a drain cycle to empty the standing water.
