REASON FOR TODAY'S CALL:

The kitchen sink is not draining properly and leaks when the water is turned on. We attempted to use the garborator on vegetables which is where the source of the initial clog is. Upon trying to dislodge the clog, a connection in the pipe under the sink began to leak.

DESCRIPTION OF WORK PERFORMED:

I used the PowerSpin drain snake to clear the kitchen sink drain bloackage. The leak was coming from a cracked ABS fitting. I replaced this fitting and tested by filling and draining both sides of the sink while running the garburator. No leaks present.
