REASON FOR TODAY'S CALL:

Both toilets not functioning properly. Fillvalves reportedly not shutting the flow of water off. *suite will be vacant Monday

DESCRIPTION OF WORK PERFORMED:

---Guest bathroom: I made an adjustment to the flush buttons and tested. Toilet seems to be flushing well for now but will likely require the same parts the master toilet requires. ---Master bathroom: The flushvalve gasket is worn out, causing it to stick in the open position when the full flush is activated. After a flush the push button has to be pressed again to engage the flushvalve stopper to drop back down and the water to refill in the tank. *These toilets were sold by a company out of China and while some of the parts can be replaced with universal parts, these flushvalve gaskets cannot. I have reached out to our suppliers in the past, as well as the company that manufactures the toilets but was unsuccessful. I reached out again and again was unsuccessful.unfortunately the only way to rectify the issue fully is to replace the toilets
