REASON FOR TODAY'S CALL:

Kitchen Faucet is leaking. You were there before for the same reason. Please advise if tenant is still using elastics to tie the hose.

## DESCRIPTION OF WORK PERFORMED:

-The nut that secures the cartridge in place worked itself loose again. I re-tightened this nut and tested. -While onsite the tenant mentioned that the toilet runs periodically and the lever handle was cracked. I found the FillValve to be malfunctioning, causing the toilet to continuously run water. I replaced the FillValve, supply line, and lever handle. Tested and in good working order.

## **TECHNICIAN RECOMMENDATIONS:**

The faucet is now functional and not leaking but I would suggest replacement of the faucet as this nut should not be loosening like this and there is the potential for the faucet to leak and cause water damage. Since this is the second time the faucet has leaked in this way I will Reach out to Delta and request they send out a replacement faucet under warranty.
