## REASON FOR TODAY'S CALL:

Shower: weird noise and vibration when temp set to mild or cold, stops when hotter.

## DESCRIPTION OF WORK PERFORMED:

There was a high frequency vibration happening in the rough-in valve when the flow of water mixed the hot and cold water together. I removed and replaced the cartridge as this is the most common culprit. Tested and no vibration present.

## TECHNICIAN RECOMMENDATIONS:

If the noise returns the next step would be to contact Teknobili and have them send out replacement parts for the internal shut off valves.
