leak in kitchen, not sure where its coming from.

## DESCRIPTION OF WORK PERFORMED:

---Dec7: The leak was emanating from under the handle of the kitchen faucet. The nut securing the cartridge in place worked itself loose, allowing water to leak through, out onto the countertop and through to the cabinet below. Since this nut should not have worked itself loose I am going to call Delta and ask them for a new faucet to be sent out under warranty. I tightened the nut securing the cartridge in place so the faucet can be used until the new faucet is installed but I informed the tenant not to turn it side to side to help mitigate the chances of the nut working itself loose again. ---Feb24: Delta sent me a new nut to replace the existing one and said it had been re-engineered so it wouldn't loosen off again. I made a trip to the unit and found that this new nut was exactly the same as the existing one. I contacted Delta again and told them i was not confident this new nut was going to be any different and convinced them to send me an entirely new faucet. ---Mar6: I installed a new Delta 469LF deck faucet and tested.
