## REASON FOR TODAY'S CALL: leaky shower faucet

## **DESCRIPTION OF WORK PERFORMED:**

---March2: I made a trip to the unit and found the shower valve cartridge to be allowing water to trickle through into the tub. The rough-in valve was originally installed too far into the wall causing the handle to rub against the trim. I will order a handle extension kit, pressure & balance control cartridges, and trim kit. ---Mar20: I installed the new pressure & balance control cartridges. During testing the Hot Integral valve failed, causing bits of rubber to clog up the pressure balance cartridge. I repaired the Hot & Cold Integral stops by replacing the washers, stems, packing, and packing nuts. I then flushed the lines and cleared the cartridge of debris before reinstalling. I tested for leaks before installing the handle extension and new trim.
