Hey Darren, We're getting a new countertop and new undermounted sink installed to it aswell as a new Fossett in our Kitchen. My wife Mariya might have allready mentioned this job to you. we'd need an appointment for you to come in the day before the countertop install, and then the day after install to connect the new sink and fosset.

DESCRIPTION OF WORK PERFORMED:

---Apr10: I removed the kitchen faucet and disconnected the garburator and drainage. The Hot & Cold shut off valvesunder the sink(connected to faucet) were not fully shutting the water off. These will have to be repaired on the next visit. I used 3/8" compression caps to ensure there is no leaking from these valves. --- Apr12: -I repaired the Hot & Cold shut off valves under the sink by replacing the washers, stems, packing, packing nuts, and handles. -I installed the new kitchen faucet, reinstalled the garburator, and repiped the ABS drainage. Tested by filling and draining the sink multiple times while running the garburator.
