DESCRIPTION OF WORK PERFORMED:

I removed the cover plate and found the stopper installed on the last visit to be bent forward(pics sent in separate email) and the cartridge itself to be cracked. this would have taken a fare amount of pressure to bend the stopper and force it past the off position. I replaced the broken cartridge and bent the stopper back so that it will block the cartridge from overturning. While this blocker does a good job of stopping the cartridge from over turning if you apply enough force it will bend it again. Please ensure future tenants are aware that the handle should NOT be turned past the off position.
