REASON FOR TODAY'S CALL:

1. Faucet in hall bathroom tub does not fully seal, preventing shower from completely turning off when trying to fill the bathtub using the faucet. Water is able to fully shutoff when finished (ie no running water problem) 2. Drain plugs in master and hall bath missing, have not been able to find replacements at Home Depot etc due to size. The top is 1 3/8" which is larger than standard, has a chrome finish if you are able to purchase or have in stock 3. Check pea trap in master and hall bath under sink due to #2 above (missing drain plugs)

DESCRIPTION OF WORK PERFORMED:

---June26: -The guest bathroom tub spout diverter was broken. I replaced the tub spout with a new Delta pull-down type diverter spout and tested. -I checked the trap in the master lavatory sink but could not find the parts missing from the drain stopper. Unfortunately the ptrap in the guest bathroom lavatory sink was glued together so it could not be opened. I will take one of the drain plugs with me and try to source new stoppers that will fit. ---June29: I was able to find 2 new stoppers that fit, I returned with the stoppers and installed.
