Current one leaks slightly (drips). We are going to Home Depot today to purchase a new kitchen faucet. 3) Repair toilet tank mechanism. Current one leaks slowly. We will ATTEMPT to purchase a repair kit at Home Depot today, but less sure about what we're doing here. (I'm not at home right now, but I will take photos of toilet tank and upload them to this service request later today.)

DESCRIPTION OF WORK PERFORMED:

-The overflow tub in the toilet was cracked. David decided to replace the toilet. He will contact us once the new toilet has been purchased. -I installed the new lavatory faucet and repiped the ABS drainage as there was a crack in the P-Trap. During testing I noticed the lavatory sink leaks when water is let run through the overflow. During normal use it does not leak. -I installed the new shower head and tested. -I installed the new customer supplied kitchen faucet and tested.
