## REASON FOR TODAY'S CALL:

Test connections between the hot water dispenser tap and tank(made by another plumber) and supply and install new Insinkerator water filter. \*Max(building manager): 778.317.9840 \*vm aug16, aug29, sep11 regarding emailing invoice.

## DESCRIPTION OF WORK PERFORMED:

When I arrived the water shut off valve(supplying the water filter/instant hot water tank) was in the off position, but the power to the instant hot water tank was on with the temperature set to low. I installed the new water filter and turned the water on. The faucet installed does not have a cold option, only hot. I ran water through the tap and turned the temperature setting on the instant hot water tank up to 3/4 max. All of the connections are dry, with no signs of leaking. -The filtered hot water tap was loose. I found that the set screw that secures it to the counter mount was not fully tightened. I tightened this set screw and it is now secure.
